Agreement for the Use and Confidentiality of GEOtExcel-2025 Files

GEOtExcel is a geotechnical engineering product developed by KAPA (KHAK AZMA PEY AFZAR Co.). This agreement is entered into by Dr. Ahmad Fahmi (hereinafter referred to as "CEO of KAPA") and the customer: [_______] (hereinafter referred to as "the Recipient"), in order to define the terms and conditions for access to and use of GEOtExcel-2025 files (Geotechnical Excel Spreadsheets), which will be shared through Microsoft 365 cloud services. This agreement comprises three pages.

1. Subject of Agreement

The Recipient will be granted access to a personalized version of the GEOtExcel-2025 (version 1) Excel-based file. This file contains educational and computational content and is to be used exclusively within the framework defined by GEOtExcel.

2. Permitted Use

- Use is limited to personal learning, technical analysis, academic projects, or professional purposes within the Recipient's organization.
- Editing input parameters and viewing outputs in the online environment (Excel Online or connected Excel Desktop) is allowed.
- The file may be used in internal meetings or classroom settings with respect to confidentiality.

3. Prohibited Actions

To respect intellectual property and ensure fair usage, the Recipient agrees not to:

- Save or export the file outside of the shared Microsoft 365 environment.
- Share the file or its contents with third parties.
- Publish any part of the file (e.g., screenshots or videos) on public platforms or social networks (such as YouTube, Instagram, Telegram, WhatsApp, Twitter, etc.).
- Share Microsoft 365 login credentials with others.
- Use the file commercially or replicate its structure without written permission from GEOtExcel.

4. Accuracy and Use of Outputs

The Recipient is responsible for independently verifying all results before using the file in geotechnical engineering decisions. Any reliance on these results is at the Recipient's own discretion. If any error is discovered, GEOtExcel will investigate and correct the issue as necessary upon notification.

5. Confidentiality and Respectful Use

The file and its contents are confidential and intended for the exclusive use of the Recipient. In case of misuse or unauthorized distribution, the Provider reserves the right to limit or revoke access.

6. Activation and Provider's Commitment

This agreement becomes effective upon signature by the Recipient and confirmation of the subscription fee payment. GEOtExcel commits to sharing the personalized file through the Recipient's Microsoft 365 account within a maximum of 7 business days after payment confirmation.

7. Duration of Agreement

This agreement is valid for **one year** starting from the date of purchase.

8. Awareness of File Structure and Hidden Sheets

Some worksheets within the GEOtExcel files are designed for internal calculations and may not be necessary for the user. These supporting sheets are intentionally hidden to simplify user experience. In addition, worksheet formulas are protected to prevent unintended modifications. The Recipient acknowledges this setup and confirms it does not hinder their use of the file.

9. Subscription Fee and Payment Options

- The official subscription period for GEOtExcel-2025 begins upon purchase, with
 access to the majority of files becoming available at the earliest possible time after
 payment. Full access to all files will be granted as soon as possible, and the
 subscription will remain valid for one year from the activation date."
- The total subscription fee for full access to GEOtExcel-2025-v1 is \$250/year (USD), covering one year from the activation date, regardless of when the subscription is purchased.
- As a launch offer, customers who choose to pay via cryptocurrency can benefit from a reduced price of 199 Tether/year, approximately equal to \$199 USD.
